

## ADDITIONAL REQUIREMENTS FOR CCW PERMIT HOLDERS

In addition to completing the requirements within the application, you must also satisfy the training requirement specified in Penal Code Section 12050(E)(i) *For new license applicants, the course of training may be any course acceptable to the licensing authority, shall not exceed 16 hours, and shall include instruction on at least firearm safety and the law regarding the permissible use of a firearm.* For your information, this is a new requirement. Also, there is a 4-hour refresher course required *prior* to renewing your permit every two years.
