Action Items:

Approve minutes of Sept 1, 2022. Corrected date for LDTAC meeting. Motion made to approve the corrected minutes by Debie, Mark seconded. 6-yes, 1-abstain, 0-nay. Need clarification if we need a meeting quorum or a RPAC quorum to pass an action item.

Informational/Discussion Items:

- 1. Discussion of housing needs and solutions. (Sajay Choudrie) Postponed. Discussion on housing at the Oct 18th meeting of the Board of Supervisor's meeting.
- 2. Review main Street Design policies and Scenic Byway Plan and follow up on speed and safety issues (Wendy Sugimura): Reviewed the Main Street Policies and the Coleville Walker Scenic Byway Plan. Discussed our frustration with lack of progress for Safety along the corridor. Would like to ask Caltrans (possibly a traffic design person) to return to the RPAC and review our Coleville Walker Scenic Byway and suggest how we might best reduce speeds and prevent illegal passing thus improving the overall safety of the road. Also discussed having the RPAC make a proposal to both the Supervisors and Caltrans to add some form of barriers along the center turn lane to prohibit illegal use of the turn lane as a passing lane.

RPAC Member Reports/comments. Mark asked about the recent court decision on Walker Lake. Katy announced Mountain Gate Park cleanup, Saturday, Oct 8th, Flu shots on Oct 12th, ESCOG Wildfire Academy on Sept 17th at 6PM. Also noted that the Fire Department funding measure is on the November ballot.
