

As second hand home owners, we just learned of the possibility of not having a doctor and health clinic in Bridgeport. My wife and I have been visiting Bridgeport since the early 1970's. Originally there was a hospital, then a clinic - and now, nothing. In 2005 we purchased a second hand home at 339 S Kingsley Street.

If the town is to exist as a delightful, historical, somewhat out of the way home for residents and tourists, it will need a staffed clinic. There is Bodie Park, fishing in Walker River (and elsewhere), horseback riding at the Hunewil Ranch, hiking the surrounding mountains, the 4th of July parade, skiing only a half an hour away at June Lake, Yosemite Park, the marine base, the local hot springs, the museum, the Indian colony, Mono Lake etc.

There is physical danger in all of these activities, i.e. snake bites, drownings, heart attacks, broken limbs, car accidents/running into deer, altercations, births... There isn't even a pharmacy in town to prescribe medications.

Ideally, the hospital in Toiyabe will take control. If so, why can't their expenses be augmented with some continuing support from Mammoth? Also, wouldn't it be possible to adjust some of the property taxes paid by us in Bridgeport to defray a portion of the hospital costs. Furthermore, would it be possible to attract medical student interns to take some of their residency requirements in such an attractive area?

We need, as a community need to put our heads together and come up with a solution to end this dilemma. I understand that money is an issue, couldn't we share a doctor from Toibe on a permanent basis. Or can we go out and look for a doctor who would like to move here, I understand that Bill Todd would like to come back, all it would take is a phone call and an invitation.

We need to remedy this pretty quickly before the tourist season comes. People aren't going to want to come here if there is no medical service here.....Think of the cost of 10,000 less people here at fourth of July weekend. That's a hefty fine for no medical care, honestly. People won't come here.

So, in closing, we all know that the Board of Supervisors has the power to make something happen. Please do this for our community.

Supervisors Corless, Johnston, Stump, Gardner and Peters:

I am writing to comment on Agenda Item 9C "Conway Ranch Grazing RFP – Direction to Staff Regarding Scheduling and Process" that will be considered at Tuesday's BOS meeting. I have a longstanding interest in how Mono County manages its Conway and Mattly Ranch properties, and I am very concerned regarding the continuation of sheep grazing on these properties. Grazing the Ranch's wet meadows is essential for maintaining the diversity of plant species found in this unique habitat remaining in the Mono Basin.

I strongly support the BOS approving, with certain modifications, the first option listed in Tony Dublino's February 7th memorandum included in Agenda Item 9C. The USFWS and/or CADFW should present their position regarding the Sierra Bighorn sheep at a separate meeting, presumably at the February 21 meeting as discussed previously. I recommend that the BOS then schedule a Workshop devoted to a discussion of the Conway/Mattly Ranch grazing issue as previously suggested by Supervisor Johnston, at a future date. This public Workshop would be an appropriate venue for Tony to present the responses to the County's "Request for Letters of Interest for Grazing Activities on Conway and Mattly Ranches". It would also allow discussion among the interested parties with differing opinions on the grazing issue, something that has not been possible at previous BOS meetings dealing with this issue. The issuance of an RFP for proposal for grazing on Conway/Mattly Ranches should be considered as an Agenda item at a subsequent BOS meeting after the Supervisors and County Staff have had time to reflect on the discussions at the Workshop.

I sense that the BOS would like to see the historic sheep grazing on Conway and Mattly Ranches continue. However I'm aware that there are concerns about the County becoming involved in a prolonged and expensive legal battle with opponents such as the Center for Biological Diversity, the USFWS and the CADFW. I suggest that the BOS examine the possibility of seeking pro bono legal assistance from the Pacific Legal Foundation < www.pacificlegal.org > that has a impressive Case Record in lawsuits involving the USFWS, the US Department of Interior and the California Fish and Game Commission.

Pro bono legal advice may also be available from the Natural Resources Law & Policy Center at the University of Arizona that was recently formed as a joint venture between the College of Agriculture and Life Sciences and the College of Law (https://extension.arizona.edu/nrulpc-brochure. The Center's mission would appear to encompass issues such as the domestic sheep grazing on Conway and Mattly Ranches vs. the USFWS reintroduction of Bighorn sheep on adjacent USFS land in the Sierra. I'm acquainted with the Dean of the UofA College of Agriculture and Life Sciences and would be willing to contact the Natural Resources Law and Policy Center on behalf of Mono County regarding the sheep grazing issue if the BOS wishes me to do so.

Please accept the following for the record regarding the Board's Agenda Item 9.C. February 7, 2017, on Conway Ranch Management. I am writing in case that the weather may prevent me from attending in person.

I urge the Board to select Action #2 from among the options presented by staff:

Schedule presentation by the USFWS and/or CADFW on Sierra Nevada Bighorn Sheep as a separate agenda item, <u>before</u> the Board considers issuance of a request for proposals for grazing at Conway Ranch.

It is logical that the presentation by the agencies to the Board and the public, with adequate time for questions and answers, on the status of the Sierra Nevada Bighorn and on the risks posed by domestic sheep grazing to Bighorn should precede the consideration of issuing an RFP for domestic sheep grazing at Conway Ranch.

Then, it makes sense to schedule consecutively, and as a separate agenda item at that meeting- a Board discussion which concludes with the BOS directing staff how to proceed on:

- 1) Whether to draft an RFP that includes proposals for sheep grazing or not.
- 2) Whether the BOS directs staff to prepare an RFP, and if so, what other options are to be considered, including: grazing of other livestock, or managing the property for wildlife habitat conservation goals, or other possible agricultural activities that are compatible with the natural resource management goals for the property.

Tomorrow, I hoping that these items can be scheduled to take place for the February 21,2017, BOS meeting, so that the agencies and the public have adequate time to plan to attend.
