"Everyone wants to get the economy moving again. But finding the balance between economic recovery and protecting public health is a difficult one.

In my view, opening our tourist economy will be unlike getting manufacturing, construction, or office work, for example, up and going. A crucial distinction is that in all of those cases, people entering the plant, the construction site, or the office building are limited and known. And they will be screened and tested periodically to ensure that they are free of the coronavirus. Another distinction is that private companies have executives who can be held responsible.

Mono County is different—its tourist economy requires large numbers of unknown and untested visitors coming into and through our communities, stopping at markets and shops that are open, and probably shedding virus. And we are a polity, not an enterprise.

So, what will Mono County do to mitigate this covid-19 risk? What regulations and routines that are analogous to those in manufacturing, construction, and offices can be created and implemented?

The key, I think, is testing—and a lot of it. Is it possible to start with testing everyone in Mono County? Can that be our county's prerequisite to Stage 2 opening? And then when visitors start coming, expecting or requiring them to either self-quarantine or to get a test?

For me and many who live here, finding reopening the Mono county economy means protecting public health and putting public safety first."

I fully understand why the fishing opener is delayed. Fishing brings substantial numbers of people to town. However, I suggest that the County consider Boating on Crowley as a separate issue from fishing.

Boating is inherently a socially distant activity and unlike fishing, no one comes here just to drive their boat. There are too many options in other places. So there would not have to be any favoritism in this policy toward residents; the demand issue takes care of it. Accordingly, the County can allow boating with little risk to public health or concern that it would attract high numbers of tourists.

Enabling boating will drive a little economic activity for the marina (dock fees, parking, gas purchases, equipment) which can be facilitated with masks and distancing. It also provides a safe way for people in the community to get outside in a time when that is needed.

Last, it is consistent with a phased approach to reopening services while balancing safety.

I suggest that the current regulations conflate boating and fishing, which have very different characteristics, and request that the County consider opening Crowley to boating on its own merits.

Dear All of Mono and Inyo County Supervisors,

First, I would like to thank you for all of your hard work during this very challenging time! I can't even imagine all of the topics you juggle every day.

I am a third generation resident and business owner in June Lake. My grandparents built their dream home in June Lake and retired here in 1987. In the 90's my mother, sister and I followed. June Lake and Mono County is our home and we love living, creating jobs, raising our children and thriving in the most beautiful place we have ever been. In 2002 my parents, Mike and Laurie Pascetti, purchased Big Rock Resort on the shore of June Lake. This is an "all in" project for our family. We do not have funds from other businesses to offset our losses and every day we grow extremely worried about the future of the business and our family as we stay closed to short term rentals. As you are very well informed, without short term rentals all of our businesses will die and Mono County will look like Bodie in a very short period of time. Opening of restaurants and shops really does nothing to help. We are a tourist town and we NEED tourists to survive.

In the beginning of March when we all became aware of this awful virus I fully supported the TEMPORARY stay at home order. It made 100% sense to stay home and let the hospital get ready and to allow supplies to be collected. Now 8 weeks later, it feels like we are being held hostage. Mono County has not experienced any of the scary things we were told would happen. While absolutely tragic, the man who did not survive had many health conditions. As we are able to test more we are finding that in our area that the virus is not deadly to our population and most have 0 symptoms.

As the manager at Big Rock, I answer questions from our guests all day long. Are you open? When will you be open? Can I rent a boat? Please tell me I can still come? Can I reserve a cabin? Do you have any other cabins for my friends? Our guests want to be here. They want to fish. They want to get out of the city. They want to bring their money to our town. They want to support us. It would be insanely heartbreaking to cancel "opener" again. I don't think the town of June Lake or our guests can take it anymore. We have all seen it. They are coming up. They are staying at friends houses. They are camping in the forest. They are poaching campsites. They are here. And we are still very healthy. At this time we must open with precautions in place but we must reopen our towns, our businesses and our open space. For the percentage of the population that is still very concerned and/or have health concerns then they need to protect themselves and those of us that are ready to take a calculated risk can start to rebuild. At Big Rock Resort - If we are unable to open for the

month of June we will need to return in excess of \$36,000 in deposits. July is over \$40,000. Can you even 'imagine the pressure we are under?

We have applied for all of the programs. The PPP does not apply to us as we are business owners without payroll. The EIDL has been a joke. We did get \$2000 but have not heard anything else. The corporations and well connected to the banks got all of the money and true small businesses like ours don't know where else to turn. We did qualify and have started to get the EDD but while it helps \$3000 a month is not even close to meeting our business expenses not to mention the personal expenses. Employees laid off or let go are making \$4k a month on EDD and they are on vacation...must be nice. We are business owners and we are working twice as hard and twice as long every day trying to figure out how to make it all work. It is exhausting!

At Big Rock we are currently spending a massive amount of time and money to create a safe, welcoming and well thought out plan for ourselves and our guests. The following is what we will have in place before June 1, 2020 to abide by the draft guidelines and to go above and beyond for our own safety and for our guests safety.

For the Cabins-

All comforters, blankets, throw pillows removed

Duvets and duvet covers purchased for easy and efficient cleaning

Today we purchased a triple hepa vacuum (\$400)

Our housekeepers will be fully equipped with PPE

Laundry bags have been purchased for the sanitary transport of linens

We will not have nor have we offered daily maid service

We do not have a pool or hot tub

All rooms will be fully sprayed down with sanitizer before the new guest arrives

All cabins will be aired out during the cleaning process

We have hired an additional housekeeper to handle the extra steps needed (a \$800 per week investment)

All keys will be sanitized in bleach and left in the rooms for no contact check in

We will send all check in documents for signature Via Docusign (\$300-\$500 per year)

For the Marina-

As always all boats are scrubbed down with Simple Green

All life jackets will be sanitized after each use and allowed to dry in the sun

All Oars will be wiped down with the bleach solution after each use

We have rented a hand sink from Mammoth Disposal (\$100 per week)

We will send all boat waiver documents for signature Via Docusign

For the Store-

I have spent the past few days building a new square site with curbside pick up so that guests do not have to come into the store

We have purchased embroidered face masks for our entire staff with our initials to prevent a mix up We will only allow 1 guest in the store at a time

We use a iPad as our register and can be completely mobile on our property to ring up guest purchases We will encourage pre paying for gifts, tackle and boat rentals for efficiency and for ZERO contact as much as possible

We will have masks, sanitizer and gloves available for our and our guests use

As well, I am an event planner. I have 10 brides that have me under contract at the moment. As I am sure you are aware, the wedding business in Mono County brings MILLIONS of dollars in, supports several businesses and employs at least 50 people that I can personally think of (catering, planners, florists, bakery, photographers, videographers equipment rentals, speciality gifts, musicians, DJs, etc) not to mention the staff that we all hire to produce these events. We must get a plan in place to give our couples the information they need so that we can move forward in planning their dream wedding in the most magical place. They picked Mammoth, June Lake, Convict Lake, Benton and Bishop over all the other places in the world because this is where they feel happy, where they feel at peace, where they want to start the next chapter of their lives.
