March 9, 2022

ACTION ITEM HIGHLIGHTS

- The RCRC Board of Directors approved a resolution honoring the accomplishments and the memory of Linda Arcularius.
- The RCRC Board of Directors voted to accept Solano County as a member of RCRC.

The RCRC Board of Directors meeting took place on Wednesday, March 9th. The RCRC Board of Directors reviewed many issues, and the following are highlights:

RCRC Chair's Report

Chair, Supervisor Dan Miller, Nevada County, reported on the RCRC Officers' recent trip to Washington, D.C. for the National Association of Counties' 2022 Legislative Conference. The RCRC Officers also met with representatives from the Administration and members of the California Congressional Delegation. Key talking points include the Bipartisan Infrastructure Act distribution of funds for various programs, Farm Bill Reauthorization, and cannabis legislation.

Staci Heaton, Senior Policy Advocate and ESJPA Deputy Executive Director, provided an update of the Rural Counties' Environmental Services Joint Powers Authority's (ESJPA). Board of Forestry State Fire Safe Regulations Update

Tracy Rhine, Senior Policy Advocate, provided an update on the Board of Forestry and Fire Protection's (BOF) Fire Safe Regulations (Regulations). On January 3rd, the BOF released another revised draft. On January 19th, RCRC, along with a local government working group, submitted comments urging BOF to reconsider its approach of the rulemaking process. At their March 2nd meeting, the BOF tabled further discussion. RCRC staff will continue to monitor and engage with BOF on the Regulations. The memo can be accessed [here](#).

California Public Utilities Commission Update

John Kennedy, Policy Advocate, Tracy Rhine, Senior Policy Advocate, and Leigh Kammerich, Policy Advocate, provided an update on RCRC's involvement at the California Public Utilities Commission (CPUC). They focused on the affordability proceeding, the biomethane proceeding, the California Advance Services Funding proceeding, the broadband deployment proceeding, and large Investor-Owned Utilities' 2022 Wildfire Mitigation Plan updates. Ms. Rhine called attention to the proposed decision regarding broadband infrastructure deployment and the proposed allocation to counties, which can be accessed [here](#). Water Issues Update

Forest Management and Wildfire Update

Staci Heaton, Senior Policy Advocate, provided an update on efforts in the Legislature and various state and federal agencies, including the United States Forest Service's 10-year strategy and key forest management and wildfire-related legislation. Ms. Heaton discussed Assembly Bill 1717 (Aguiar-Curry), which would expand the definition of "public works" to include fuels reduction work paid for by public funds and require prevailing wage. GSFA BOD MEETING HIGHLIGHTS

The GSFA Board of Directors meeting took place on Wednesday, March 9th. Here are some of the highlights:

- The GSFA Board of Directors approved the reauthorization of the GSFA Financing Action Team, including GSFA Resolution 22-02: Authorizing the GSFA Financing Action Team to Review and Approve Financing and Related Actions for Multi-Family, Public Infrastructure, and Real Property Improvement or Rehabilitation Projects, and Issuance of Mortgage Revenue Bonds and Property Assessed Clean Energy Bonds. As recommended by the GSFA Chair, the reappointed members are Supervisors Bob Williams (Tehama County), Daron McDaniel (Merced County), Rex Bohn (Humboldt County), Les Baugh (Shasta County), and Jack Garamendi (Calaveras County).
