Dear Supervisor Duggan,

Thank you for the notice regarding the increase in fees regarding our transfer station and garage. I note that the fee for wood waste has already gone up substantially in the last month or so. As someone who continues to utilize the Chalfant transfer station for my garbage needs, I respectfully request that fees in the Tri-Valley area be maintained at their current rate. Over the last 18 years the fees have gone up for a truckload of household garbage from 50cents (which I admit was a little ridiculous) to \$5.00 to \$7.50 which is huge proportional increase. As someone who recycles and attempts to minimize their waste, I can usually go 5 to 6 weeks between dump trips for normal household garbage. I would not use a commercial service as I wouldn't be able to fill their can every week for pick up. Unfortunately, neither company will do a monthly pickup, thus I am dependent on the Chalfant transfer station as long as I am able to get the cans in the truck.

With respect to the wood waste, the vouchers have been a god send for me as well as all of my neighbors on both sides of the highway. The older homes have trees which have reached the end of the lifespans and need to be removed. Others, such as my house, just need to be removed because there are not firesafe under the current guidelines. I know myself, I would hesitate to remove these items without the wood waste, especially since the burning season seems to be shorter and shorter every year, and probably contributes to climate change in a negative way. When I go to the wood waste section of the transfer station, I can see that people have been very busy, getting rid of highly flammable, already dead, materials in their yards and they need to be encouraged to continue to do so as we still have several homes in the area that probably would be cited by CDF if they came out here.

I know this is a continual problem and better solutions need to be found but I think to overcharge persons for the right to get rid of their garbage is unfair and not smart as it will encourage people to keep that stuff on their property, creating health and hazard issues for them as well as the entire neighborhood.
