Rural Counties Representative California Urges State to Make Past Due Payments to Counties- RCRC has issued the following press release and has asked all rural counties help pressure the administration to make required payments to the counties. Mono County will be participating in this effort and is analyzing monies due.

From the RCRC Press release:

"The Rural County Representatives of California (RCRC) urged Governor Jerry Brown to honor the State's legal and financial obligations to counties as related to the Department of Fish and Wildlife's (DFW) Payment in Lieu of Taxes (PILT). RCRC requests that the State include current and past due payments in the 2014-15 State budget and resume annual PILT payments as legally obliged.

"Counties across the state are doing everything in their power to reduce expenses and tighten budgets to fund critical programs and services for residents," said Nate Beason, RCRC First Vice Chair and Nevada County Supervisor. "All the while, the State owes 36 California counties more than \$17 million in past due PILT payments. The Administration has indicated that paying off California's debts is one of their top priorities. These past due PILT payments are one of those debts."

California PILT was established in 1949 to offset adverse impacts to county property tax revenues that result when the State acquires private property for wildlife management areas. Fish and Game Code Section 1504 specifies that when income is derived directly from real property acquired and operated by the State as wildlife management areas, the DFW shall pay annually to the county in which the property is located an amount equal to the county taxes levied upon the property at the time title was

transferred to the State. The DFW has neglected to make annual PILT payments in more than a decade."

Town of Mammoth Lakes begins Solid Waste conversation – Supervisor Larry Johnston, Tony Dublino and I attending the Town of Mammoth Lakes October 16th Council meeting where an item on solid waste was being discussed. The item of interest was the staff presentation on the state AB 341 requirements that requires the Town to report on ongoing diversion efforts. The Council agreed to agendize a broader discussion in the next month or so and staff will be following up with Town Manager Dan Holler to request County participation. This upcoming Council discussion could be the first steps in opening the broader, needed public dialogue on all jurisdictions solid waste issues.

Tony Dublino sent a letter to the Council last week (attached separately to Board Update) and again expressed the County's ongoing interest and efforts to support a long term solid waste solution. Mayor Wood appreciated Tony's information.

Boulder Creek Prescribed Burn Response – In response to Mono County's request for a delay in the prescribed burn in the Sequoia National Forest, the Sierra Forest Legacy group has sent a letter supporting the burn. The Board sent a letter requesting a delay in order to reduce the impact of more smoke on the health of our residents and of the local economy which had seen great impacts from an unprecedented smoky summer.

No response from the Forest Service has been received. The Sierra Forest legacy response is attached for review and the County is awaiting the Forest Service's response which was delayed due to the Federal Government shut down.

YOSEMITE NATIONAL PARK REOPENS TO VISITORS – The Yosemite Gateway Partnership provided an update (Attached spate to Board Update regarding the great news of the re-opening of Yosemite.

The Update from Wednesday evening is as follows:

"Yosemite National Park reopens to park visitors tonight, October 16, 2013. Visitors can access public areas and roads immediately while facilities and other public services are brought back on-line. Yosemite National Park has been closed since October 1, 2013 due to the government shutdown.

"We are excited to reopen and welcome visitors back to Yosemite," stated park superintendent Don Neubacher. "Autumn is a particularly special season to enjoy Yosemite's colorful grandeur."

Major highways and roads leading into and through Yosemite National Park, including the Glacier Point and Mariposa Grove roads, are open to vehicles. Park visitor centers will reopen and Ranger-led programs will resume on October 17. Visitors are urged to consult the Yosemite Guide for a list of programs.

Valley campgrounds in Yosemite will reopen on October 17. Those with reservations will be able to check in by noon. First come, first serve sites at Camp Four, Wawona and Hodgdon are also available.

Delaware North Parks & Resorts at Yosemite, Inc., the park's primary concessioner, is reopening facilities and will begin to welcome guests immediately.

The Ansel Adams Gallery, located in Yosemite Village, will also reopen.

Public Health

Public Health Officer issues proclamation to protect health care workers from influenza – It's that time of year again – flu vaccine is being offered to all health care workers (HCW). The most efficient method of preventing cases of influenza in the community, with the resulting morbidity and mortality, is by the use of pre-exposure influenza immunization.

Dr. Johnson issued an order mandating that all licensed healthcare facilities, agencies, and entities in Mono County, including within the Town of Mammoth Lakes, implement a program in which all HCW at such facility, agency, or entity receive an annual influenza vaccination for the current season, unless the HCW signs a declination (e.g., stating a medical contraindication, or philosophical or religious belief), and wears a mask while in contact with patients or working in patient-care areas.

Facilities, agencies, and entities covered by this order shall determine the means of implementation and enforcement within their organization (e.g., adoption of personnel policies, use of incentives or penalties, suspension of professional privileges, etc.). Further, Dr. Johnson is recommending that each health care facility adopt an easy way to identify those health care workers who have received the influenza vaccine, e.g., placing a sticker on the health care worker's badge following vaccination.

The goal is a >90% vaccination rate in all facilities/entities within Mono County and this order applies to each influenza season, defined as November 1^{st} of one year to March 31^{st} of the following year, unless the order is rescinded.

If data in a particular year demonstrate that the influenza season is different than Nov 1 to March 31, this period may be changed by further order, as determined by the Health Officer based on local, regional, state, and national surveillance data, and communicated to all facilities/entities in writing.

Community Center Solarization continues! - The solar projects at Lee Vining Community Center and the Crowley Lake Community Center are also progressing rapidly as the crew focuses on staying ahead of the winter weather.

These systems include photo voltaic panels as well as solar hot water which will reduce our energy bills as well as our carbon footprint. The solar hot water system at the CLCC will also introduce hot water into the



boiler system which will reduce our propane as well as electricity bills. The funding for these projects came from a Clean Air Projects Program grant.
