Collaborative Planning Team — Federal, state, and local agency directors were joined by numerous public attendees Tuesday to discuss planning issues: USFS staff Debra Schweizer and Leeann Murphy presented an update on the Inyo Forest Plan, noting that comments are still sought; Ryan Dermody of Caltrans reviewed results of an origin & destination survey for Mono and Inyo counties; Deanna Dulen distributed a Devils Postpile historic survey; CDD analyst Brent Calloway presented a PowerPoint on the Housing Element update; and Carl Benz of USFWS reviewed potential listing of sage grouse as threatened/endangered.

**Building inspector reaches pinnacle** – Jim Shoffner attained the designation of Master Code Professional (MCP), the highest level of certification that the International Code Council (ICC) offers. ICC has certified thousands of individuals over many years, but only a small, select number attained this high level of achievement. Currently, just over 700 individuals have MCP certification. Obtaining this level of certification demonstrates commitment to the profession, diverse knowledge of codes, and a high degree of self-initiative.

I wanted you to know EVERYONE from Mono County really "shined" last night, and this morning! Sheriff's folks, Paramedics, Bridgeport Fire, Dr. Johnson at County Health was all over this in my first phone call to him this morning. The press releases speak to the fact emergency folks in Mono County work well together, and we depend on one another. Here is a Sunday night event that involves 50-60 people, and it all goes well, everyone is cared for....and no long-term harm comes to anyone. I did about four press telephone interviews this morning....all of the reporters noticed how quickly, efficiently and coordinated this event was handled.

# **Information Technology**

Digital 395 - This past week, California Broadband Cooperative (the operating company of Digital 395) turned on service for all of Mono County's remote sites which will allow us to bring Internet/network to those locations in the coming weeks. The next step in the project is for IT staff to deploy equipment at each location which will allow for County staff and the general public to connect to wireless networks at those locations. This effort will begin

in early March, with the top priority being sites that house County staff, followed by community centers, and then other locations behind that. We anticipate the effort taking a few months to complete.

IT Space Lease Innovation Idea- Over the past couple months, the IT department has been working with Town and County administration on securing a new office location for Mammoth IT staff. On February

19<sup>th</sup>, Town Council approved a lease agreement which would allow the County to sub-lease the old Town Finance Department space, located on the second floor of Minaret Mall.

This idea is being brought to the Board for their review. If approved the move is estimated to save the General Fund \$27,000 annually. The new space is approximately 35% larger than the existing IT space, has a room which will better accommodate our servers and infrastructure (including future expansion), and will cost approximately one-third of what is currently being paid for the Sierra Center Mall space.

### **Public Health**

Mono County Paramedics play vital role in response to Bus Incident - Members of Mono County EMS, Bridgeport Fire Dept., Mono Sheriff's Office, and CHP responded to a "multi casualty incident" at the Bridgeport Shell station last Sunday Evening. What began as a simple "sick female" call quickly turned into an appx. 40 patient, possible Carbon Monoxide poisoning call. Patients were assessed rapidly and it was determined 13 of the 40 would need transport. Mammoth Hospital was contacted, and it was determined that 8 patients would go south, and 5 would head north to CVMC. Medics 1, 7, and 2 transported the patients, who all improved in route to the respective hospitals. CHP did determine it was a carbon monoxide leak after exam by highly trained techs from their agency.

It is important to keep in mind this was an extraordinary event that was handled professionally by our EMS crews, and the other agency first responders. An after-action plan and debriefing is to be held next week in Bridgeport, and further updates to follow.

Also, I would like to thank Leslie, Rose and especially Penny in Finance for allowing the billing and collection for our agency to be moved "in house." This will allow strict oversight of a system that has been farmed out over the last few years, should increase revenue, and makes our system more reliable.

#### Sheriff's Office

1. MONET conducted (2) search warrants in the Town of Mammoth Lakes with Supervisor Fesko monitoring the happenings. Narcotics and suspect(s) were seized, detained and/or arrested.

- 2. Sheriff's Officer(s) were involved in a pursuit over the weekend. One suspect was taken into custody, while the other fled the scene into Nevada. Our officer terminated the pursuit for safety reasons, and the Nevada agencies ended up losing the suspect in the Reno area.
- 3. Sheriff's Officer(s) were involved in a rescue operation in a very difficult canyon of the White Mountains on Thursday. Multiple agencies were involved in this 5 hour operation: Mono County Sheriffs, Mono County Paramedics, Mono County Search and Rescue, Chalfant Valley Fire, White Mountain Fire, CHP and Interagency. A vehicle with two occupants rolled down a canyon, with the two occupants sustaining injuries and having to be extracted by the SAR team and others. The crash site was reached by using the Sheriff's Office Quads and Ranger OHV vehicles which were brought to the scene as no standard vehicles could safely negotiate the off road conditions.
