Board holds Special Board meeting to address Fire impacted residents issues – on Tuesday, March 3rd, the Board of Supervisors held a special evening meeting to continue county efforts to support the recovery for those impacted by the Round Fire.

Over 65 people attended the Board of Supervisors meeting held at the Crowley Community Center. The entire Board was present and received a report in response to their request to support fire impacted residents efforts to quickly and safely rebuild lost homes.

Presentations included *Jeff Walters, Tony Dublino, Sheriff Ingrid Braun, Scott Burns, Tom Perry, Jim Leddy, Lynda Salcido, Assessor Barry Beck, Louis Molina, Roberta Reed* and from Cal recycle *Todd Thaulhamer* and from Cal OES, *Melinda Stehr* Emergency Services Coordinator and *Wes Minderman* of Cal Recycle.

The entire evening was focused on ensuring that the County is doing all it can within limited resources to facilitate the rapid rebuilding and recovery to a community ravaged by the February 6th Round Fire. The Board concluded by giving direction that will ensure ongoing coordination with property owners and support for their efforts.

Community Development

LDTAC – The Land Development Technical Advisory Committee (LDTAC), comprised of Environmental Health, Public Works, and Building/Planning/Compliance, provides technical review of potential development projects in the county. At Monday's meeting, *Gerry Le Francois* discussed a proposal for 30 units (55 rooms) of transient occupancy along Topaz Lake. Courtney Weiche reviewed a proposed Transient Rental Overlay District in the community of Twin Lakes/Bridgeport, and a conditional use permit for a deck at June Lake. The conditional use permit will be considered at 10:30 a.m. in a public hearing before the Planning Commission during its March 12 meeting at the board chambers in the county courthouse in Bridgeport.

Chalfant Valley RPAC – At Monday evening's meeting a group of community members considered transit needs, received a presentation on the countywide strategic planning process from *Jim Leddy*, and

discussed several local issues with *Supervisor Stump* and *Brent Calloway* including rehabilitation of the baseball field, communications infrastructure, and Area Plan policies.

The Board pulled from contingencies money to maintain services at current levels in the Paramedics EMS program and in the Roads department. The Board will be receiving a presentation on March 17th on establishing a process to review the long term sustainability of the current Paramedics program. Dear Valued Stakeholders,

As many of you have heard in the news, our health plan partner Anthem Blue Cross disclosed late last night that hackers breached its computer systems and the personal information of its members. Like you, we are very concerned and frustrated about this unacceptable breach. We have been in touch with Anthem this morning to ensure they are doing everything possible to protect our members and their families who are enrolled in the plan.

Anthem has said that the breach included access to customers' names, dates of birth, Social Security numbers, member ID numbers, addresses, phone numbers, email addresses and employment information. However, no personal health care information or credit cards numbers were compromised.

Anthem will individually notify current and former members whose information has been accessed and will provide credit monitoring and identity protection services free of charge so that those who have been affected can have peace of mind going forward.

Anthem has also established a website -- <u>www.anthemfacts.com</u> -- where members can access information about the situation as well as a dedicated toll-free number for questions about this incident: (877) 263-7995. We are also

promoting this information through our social media channels and with stakeholders like you and encourage you to share it with your members and networks as well.

We will keep you updated with any new information we learn on this issue and appreciate your help and partnership in protecting our members and their personal data.
