Community Development

Airport Land Use Commission – A commission that meets only as needed met Monday to discuss airport land use planning matters for airports in Mono County. The commission, which is comprised of two County Supervisors (*Stump* and *Fesko*), two Town of Mammoth Lakes designees, and two airport representatives, including *Jeff Walters*, received reports on commission purpose provided by Gerry Le Francois and on new airport layout plans by *Garrett Higerd* and Town staff.

Antelope Valley RPAC – At its Thursday meeting, the RPAC discussed Mountain Gate phase II construction and suggestions for phase III. Supervisor *Tim Fesko* announced a ribbon cutting in May for phase II. *Jeff* **Ulrich** of USFS described pinyon removal and various treatments, as well as a possible fee increase for cutting Christmas trees on USFS land. Community members discussed a potential dog park with proponent Ellie Espinosa. CAO Jim Leddy returned to discuss the Strategic Plan. The RPAC requested that staff apply for a planning grant from the Toiyabe Community Wellness Program to pursue community trails planning.

Sunrise sage grouse counts – At the crack of dawn this morning, Community Development staffers, including Courtney Weiche, Brent Calloway, Nick Criss, and Wendy Sugimura, as well as representatives from Eastern Sierra Land Trust and the Audubon Society, met with biologists from the BLM and LADWP in Long Valley to participate in annual sage grouse population counts. Using binoculars and spotting scopes, the team visited two leks (specific areas the grouse congregate to mate) and observed and counted dozens of male sage grouse performing their ritual mating displays. Thanks to BLM for a grant to fund staff involvement in this annual grouse count. A decision by the US Fish & Wildlife Service on listing the grouse as threatened is expected later this month.

Debris Management Training

Date: Wednesday, April 29, 2015

Overview - California has experienced floods, fires, earthquakes and even civil unrest. These events created tons of debris that not only posed an immediate threat to public health and safety and the economic recovery of the state, but were also a hindrance to response and recovery actions. In the past, this debris was generally burned or



buried with little consideration to landfill capacity, air pollution or effects on the environment.

These practices caused serious concerns for environmental scientists, emergency managers and the general public. Steps taken to address these concerns caused the costs of debris removal and disposal to quickly escalate. In fact, data compiled by the Federal Emergency Management Agency revealed that debris management costs are as much as 40% of the total disaster dollar amount nationwide.

In response to the issues facing local governments with increasing debris types and quantities, the California Governor's Office of Emergency Services (CalOES) conducts Debris Management Training at no cost to local governments. This training is geared for anyone who has a role in emergency and/or debris management operations. Anyone directly involved in debris planning and operations (public works, civil engineers, emergency planners, code enforcement, finance, etc.) is encouraged to attend this training.

During this training, Cal OES staff provides information that helps eligible applicants hold on to all the disaster dollars that they are entitled. The training shows how to identify various disaster related debris issues, discusses possible solutions, and provides additional related information and guidance for successful debris management operations. The main focus of the training highlights the following:

- Debris Type
- Eligibility & Reasonable Costs
- Debris Contracting

- Debris Forecasting & Estimating
- Debris Monitoring
- Debris Management Plan

<u>Target Audience --</u> The workshop is geared for state and local government participants directly involved in debris planning and operations (public works, solid waste, civil engineers, code enforcement, finance, etc.). The workshop focuses on debris management plan development.

These two men showed determination and dedication to continued care for a Mono County patient, during the transfer of care from

an ambulance to another medical facility. They properly identified a medical emergency requiring immediate assistance that fortunately Care Flight was able provide at that time. And then ensured

appropriate and necessary continued care for this patient was met by Care Flight.

Bullock started as a paramedic for Mono County in October 2004 and was promoted to Station Captain in May 2014. He has been in the emergency medical field for approximately 18 years. Mono County

Risk Management

April is Distracted Driving Awareness month! Thank you to Risk Manager *Sarah Messerlian* for providing the following information. Additional information on this issue is attached to the Board Update!

Here's a scary statistic:

If you text and drive, you're 23 times more likely to have a car crash. Texting while driving has become the number one driving distraction for many people. Drivers need to be aware of the dangers and keep their attention on the road, not on their cell phones or other mobile devices.

How big is the problem?

Each day in the United States, more than 9 people are killed and more than 1,153 people are injured in crashes that are reported to involve a distracted driver. Distracted driving is driving while doing another activity that takes your attention away from driving. Distracted driving can increase the chance of a motor vehicle crash.

There are three main types of distraction:

<u>Visual</u>: taking your eyes off the road; <u>Manual</u>: taking your hands off the wheel; <u>Cognitive</u>: taking your mind off of driving.

Distracted driving activities include things like using a cell phone, texting, and eating. Using invehicle technologies (such as navigation systems) can also be sources of distraction. While any of these distractions can endanger the driver and others, texting while driving is especially dangerous because it combines all three types of distraction.
