22	modified irrigation ditches (raceways), and where the County has also authorized a licensee or other party to engage in certain fishing activities as a form of nonprofit fundraising to benefit the Conway Ranch. The licensed fish- rearing and fishing area is also described as the south half of the southwest		
23			
24	quarter of Section 6, Township 2 North, Range 26 East, MDM, in the County of Mono, State of California, according fo the official plat thereof.		
25	E. "Night" means the period beginning one hour after sunset and ending one		
26	hour before sunrise, local time.
