- . Meet with counseling for assistance in selecting courses and educational planning to determine your pathway to a certificate or associate degree.
- Maintain at least 2.5 GPA each semester.
- . Complete 10 hours of volunteer service for your community each semester.
- . Complete a simple online check-in form weekly with the Scholarship Coordinator throughout the semester.
- . Attend monthly MLF scholarship brunches, typically held the last Friday of each month.
- Participate in scheduled scholarship check-ins/one-on-one discussions with MLF staff as appropriate.
- . Conduct yourself with integrity and behavior conducive to the values of MLF.
- . Check your Cerro Coso email account regularly for correspondence from Cerro Coso and MLF.

Free 2024 Tax Help Available

Our free tax preparation service, run entirely by volunteers, serves low and moderate income taxpayers.

Mammoth Lakes Library until April 15th Mondays, Wednesdays, and Thursdays 1:00pm to 4:30pm

The process has three basic steps:

- 1. Ahead of your first appointment you will pick up an intake packet from the library front desk. Read and fill out all of the forms in the intake packet prior to your first appointment, especially the Intake/Interview booklet which was revised.
- 2. At your first appointment, a counselor will meet briefly with you to go over your intake packet and tax forms. They will be kept until your second appointment. Your tax return will be prepared and quality reviewed offsite at the counselor's homes.
- **3.** On your second visit (about a week later), a counselor will meet briefly with you to go over your finished return, obtain your signatures, and return your tax materials to you. Your tax return is e-filed that same day.

Earned Income Tax Credit (EITC) and Child Tax Credit (CTC) Eligibility:

If you don't have children you could qualify for an EITC of up to \$632 if:

Age:

You were between 25-64 years old on December 31, 2024.

2024 Income:

You earned less than \$18,591 (\$25,511 if married).

If you are not a U.S. citizen you could qualify if:

- ▶ EITC: You, your spouse, and any child you claim have a valid Social Security number (SSN).
- CTC: Any child you claim has an SSN. You and your spouse must have an SSN or Individual Taxpayer Identification Number (ITIN).

If you have children you could qualify for the EITC and CTC if:

Residency:

▶ Your children lived with you for more than half of 2024.

Age – children must be:

- ▶ EITC: 18 or under on December 31, 2024 (full-time students can be under 24 and children who have a permanent and total disability can be any age).
- ► CTC: 16 or under on December 31, 2024.

Income for 2024:

- For the federal CTC, if you earned more than \$2,500, you could claim a credit of up to \$2,000 per child.
- ▶ For the federal EITC, your earnings must be lower than the following limits:

Number of Children	Single workers with income less than:	Married workers with income less than:	EITC up to:
1 child	\$49,084	\$56,004	\$4,213
2 children	\$55,768	\$62,688	\$6,960
3 or more children	\$59,899	\$66,819	\$7,830

It's not too late to claim 2021 expanded tax credits!

Because of the pandemic, the EITC and Child Tax Credit were expanded and made available to more people. That expansion has ended, BUT if you were eligible for the 2021 expanded EITC, the 2021 expanded Child Tax Credit, or any of the three rounds of stimulus checks and didn't claim them, it's not too latel Visit IaxOutreach.org/expanded to learn more.

➤ CTC: Cualquiera de los menores que usted reclame tiene un SSN. Usted o su esposo/a debe tener un SSN o un número de Identificación Personal del Contribuvente (en inglés ITIN).

¿Cumplo con los requisitos?

En la temporada de impuestos, justed podrá deber menos impuestos y obtener un reembolso con el Crédito por Ingreso del Trabajo (en inglés ETTC) y el Crédito Tributario por Hijos (en inglés ETTC) Si Trabajó en 2024, puede ser elegible para estos crédito.

Beneficios públicos:

Check your mailbox often for your new card. You do not need to visit a County office to receive your card, and do not need call to activate your new card. All existing benefits will transfer automatically to your new EBT card and your PIN will stay the same.

- All personal information has been moved to the back of your new card.
- A card expiration date and Card Security Code (CSC) have been added to increase card security.
- The expiration date is for the card only and does not represent your benefits expiration or expungement.
